Sangeet Natak Akademi: An Introduction

Sangeet Natak Akademi — India's national academy of music, dance and drama — is the first national academy of arts set up by the Republic of India. It was created by a resolution of the (then) Ministry of Education, Government of India, dated 31 May 1952, which was notified in the *Gazette of India* in June 1952. The Akademi became functional the following year, with the appointment of its first Chairman, Dr P.V. Rajamannar, and the formation of its all-India council of representatives, the General Council. The first President of India, Dr Rajendra Prasad, inaugurated it on 28 January 1953 at a special function held in the Parliament House. Maulana Abul Kalam Azad, then Union Minister for Education, in his opening address at the inauguration of the Akademi, said:

India's precious heritage of music, drama and dance is one which we must cherish and develop. We must do so not only for our own sake but also as our contribution to the cultural heritage of mankind. Nowhere is it truer than in the field of art that to sustain means to create. Traditions cannot be preserved but can only be created afresh. It will be the aim of this Akademi to preserve our traditions by offering them an institutional form . . .

In a democratic regime, the arts can derive their sustenance only from the people, and the state, as the organized manifestation of the people's will must therefore, undertake . . . maintenance and development {of arts} as one of {its} first responsibilities . . .

The Akademi's charter of functions was expanded along the original lines in 1961, when Sangeet Natak Akademi was reconstituted by the Government as a society and registered under the Societies Registration Act of 1860 (as amended in 1957). These functions are set down in the Akademi's Memorandum of Association, adopted at its registration as a society on 11 September 1961.

Since its inception the Akademi has been functioning as the apex body in the field of performing arts in the country, preserving and promoting the vast intangible heritage of India's diverse culture expressed in forms of music, dance and drama. In furtherance of its objectives the Akademi coordinates and collaborates with government and arts academies of different States and Union Territories of the Union of India, as also with major cultural institutions in the country. The Akademi establishes and looks after institutions and projects of national importance in the field of the performing arts. The National School of Drama was set up by the Akademi in 1959. Two national institutions of dance — Jawaharlal Nehru Manipur Dance Academy in Imphal and Kathak Kendra (National Institute of Kathak Dance) in New Delhi — were set up in 1954 and 1964 respectively. National Projects of Support to Kutiyattam, the age-old Sanskrit theatre of Kerala, to Chhau dance of eastern India, and Sattriya traditions of Assam have been launched subsequently. After ten years of intensive work under the Kutiyattam project, the Unesco declared Kutiyattam as a Masterpiece of Oral and Intangible Heritage of Humanity in May 2001. The Akademi inaugurated its centre for Kutiyattam, Kutiyattam Kendra, in Thiruvananthapuram on 27 May 2007.

The Akademi Awards are the highest national recognition conferred on practising artists. The Akademi also confers Fellowships on eminent artists and scholars of music, dance and drama. The Akademi's

Fellowship (Akademi Ratna) carries a purse money of Rs. 1 Lakh and the Akademi Puraskar (Akademi Award) carries a purse of Rs. 50,000.

From the year 2006, the Akademi has also instituted Awards to young artists in the name of Ustad Bismillah Khan, which are called Ustad Bismillah Khan Yuva Puraskar. The number of Yuva Puraskars is 33. The Yuva Puraskar carries a purse of Rs. 25,000.

The Akademi subsidizes the work of institutions engaged in teaching, performing, or promoting music, dance or theatre; gives grants-in-aid for research, documentation, and publishing in the performing arts; organizes and subsidizes seminars and conferences of subject specialists; and documents and records the performing arts for its audio-visual archive.

The Akademi's archive, comprising audio/video tapes, photographs, and films is the largest in the country and is extensively drawn upon for research on the performing arts. The Akademi maintains a reference library consisting of books in English, Hindi, and some regional languages. The Akademi has a gallery of musical instruments in Rabindra Bhavan, New Delhi, where more than 200 musical instruments are displayed. It also has a documentation unit, which has recorded maestros in the field of music, dance and theatre. The Akademi also publishes literature on relevant subjects on a small scale.

As the apex body specializing in the performing arts, the Akademi also renders advice and assistance to the Government of India in the task of formulating and implementing policies and programmes in the performing arts. Additionally, the Akademi carries a part of the responsibilities of the state for fostering cultural contacts between various regions in India, and between India and the world.

Sangeet Natak Akademi is an autonomous body of the Ministry of Culture, Government of India, and is fully funded by the Government for implementation of its schemes and programmes. The management of Sangeet Natak Akademi vests in its General Council. The general superintendence, direction and control of the affairs of the Akademi vests in the Executive Board, which is assisted by the Finance Committee, Grants Committee, Publication Committee and Advisory Committees for Music, Dance, Theatre, Documentation and Archives, Puppetry and Folk & Tribal Arts. The objectives of the Akademi are more specifically stated in its Memorandum of Association (excerpts: Appendix I). Shri Ram Niwas Mirdha is the Chairman of Sangeet Natak Akademi and Shri Kavalam Narayana Panikkar is Vice-Chairman. A list of the Members of the General Council, Executive Board and Advisory Committees is at Appendix II.

The Secretary and Principal Executive Officer of the Akademi is Shri Jayant Prakash Kastuar. The Secretary is assisted by Deputy Secretaries for Music, Dance, Drama, Coordination, Finance, Administration, Publication, Documentation, the Librarian of the Akademi and the Directors of Kathak Kendra and Jawaharlal Nehru Manipur Dance Academy, both constituent units of the Akademi. The management of the above two institutions vests in the Executive Board of the Akademi, which in turn is assisted by the Advisory Committees of the two constituent units. Reports on the activities of these institutions are included in this Report. Meetings of the General Council, the Executive Board, and various committees constituted by the Executive Board are listed at Appendix III.

AWARDS OF SANGEET NATAK AKADEMI: 2006 AND 2007

Sangeet Natak Akademi Awards 2006

The General Council of the Akademi met on 27 December 2006 and 15 February 2007 elected five eminent personalities in the performing arts as Akademi Ratna-s (Fellows). Thirty-three eminent artists were selected for Akademi Awards for 2006. The Akademi Awards Presentation Ceremony was held in Kamani Auditorium, New Delhi, on 1 March 2007. The awards were presented by the President of India, Dr. A.P.J. Abdul Kalam, in the presence of Smt. Ambika Soni, Union Minister for Tourism and Culture, Shri Ram Niwas Mirdha, Chairman of the Akademi, and Shri Kavalam Narayana Panikkar, Vice-Chairman of the Akademi.

Sangeet Natak Akademi Awards 2007

The General Council of the Akademi which met on 18 December 2007 elected one eminent personality in the performing arts as Akademi Ratna (Fellow). The General Council also selected 33 eminent artists for Akademi Puraskar (Awards) Awards for the year 2007. The Akademi's Fellowship (Akademi Ratna) carries a purse of Rs 1 lakh and Akademi Puraskar-s (Awards) carry a purse of Rs 50,000, a shawl and a tamrapatra. EXHIBITIONS AND FESTIVALS

Putul Yatra 2007 Chandigarh: 2-15 April 2007

A festival and exhibition of Indian puppetry was held in collaboration with Punjab Arts Council, Chandigarh. The festival performances were held from 2 to 8 April 2007 and an exhibition of traditional and contemporary puppets of India was held from 3 to 15 April 2007 at the gallery of Punjab Kala Bhavan, Chandigarh. As many as fourteen traditional and contemporary puppet groups presented performances — Benir Putul of West Bengal, traditional string puppet of Assam, traditional string puppets of Rajasthan, traditional rod and string puppets of Karnataka, shadow puppets of Andhra Pradesh, traditional string puppets of Pondicherry and contemporary puppets from Delhi, Gujarat, West Bengal and Maharashtra were presented. Putul Yatra, an exhibition of Indian puppets, was inaugurated by Shri Gursharan Singh, Fellow of the Akademi, on 3 April 2007. The exhibition showcased 208 traditional and modern puppets and associated musical instruments from the archives of the Akademi. Also on display were puppets made by Shri Dadi Pudumjee and Shri Puran Bhat. Puppeteers of Chandigarh gave live demonstrations at the exhibition.

Festival of Music and Dance in Jammu:

13-15 April 2007

Sangeet Natak Akademi sponsored a programme of music and dance as a segment of the Jammu Festival organized by the Tourism Department of Jammu and Kashmir Government from 13 to 15 April 2007 in Jammu. The programme featured prominent dancers and musicians, as follows:

13 April

Sitar and Sarangi duet by Prateek Choudhary and Kamal Sabri, accompanied by Akram Khan on Tabla and Fateh Singh Gangani on Pakhawaj; Odissi dance by Kiran Segal and her group.

Death Anniversary of Rajiv Gandhi:

21 May 2007

The Akademi presented the cultural component of a solemn ceremony held at the Samadhi of Rajiv Gandhi, former Prime Minister of India, at Veer Bhumi in observation of his death anniversary on 21 May 2007. The death anniversary included the rendition of vedic chants and hymns by Gandharva Mahavidyalaya, composed by Shri Madhup Mudgal.

The ceremony were attended by the Prime Minister of India, the Vice-President of India, the Chief Minister of Delhi and members of the Gandhi family.

Inauguration of Kutiyattam Kendra,

Thiruvananthapuram: 27 May 2007

On the basis of a resolution passed by Sangeet Natak Akademi in July 2007 to upgrade the Akademi's existing project in support of Kutiyattam, the Akademi set up a Centre for Kutiyattam in Thiruvananthapuram on 27 May 2007. The project supporting Kutiyattam was launched by the Akademi in 1991 for the preservation and promotion of this classical Sanskrit theatre tradition of Kerala. The programme was designed as a total care programme providing regular support to the existing institutions and artists of Kutiyattam by way of funding of training activity and regular performance opportunities in and outside Kerala, besides making provision for maintenance grants, students' performances, copying and preservation and old manuscripts, and an annual festival of Kutiyattam. In the year 2001, the Unesco declared Kutiyattam as a Masterpiece of Oral and Intangible Heritage of Humanity. The proclamation ceremony was organized by the Akademi in New Delhi. Subsequently, the Ministry of Culture also started a scheme for Kutiyattam providing support to the Art. In the light of the above developments, the Akademi set up a National Centre for Kutiyattam in

Thiruvananthapuram. The centre was inaugurated by Shri R.L. Bhatia, Hon'ble Governor of Kerala in the presence of Shri Ram Niwas Mirdha, Chairman, Sangeet Natak Akademi, Shri Kavalam Narayana Panikkar, Vice-Chairman, Sangeet Natak Akademi, members of the Executive Board of the Akademi and the Kutiyattam fraternity on 27 May 2007.

Young Theatre Artists Workshop, Khairagarh: 3 July – 1 August 2007

A month-long workshop was organized for the benefit of young theatre artists of Chhattisgarh at Khairagarh from 3 July to 1 August 2007. The workshop was held in collaboration with Indira Kala Sangeet Vishwavidyalaya and covered the first phase of the Akademi's programme in the Central Zone by providing basic training to young theatre artists.

As many as 23 young theatre artists between the age of 21 and 35 years, including two female participants, were selected through interviews held at Raipur, capital of Chhattisgarh. Participants came from various parts of the State such as Jashpur, Korba, Rajnandgaon, Durg, Raipur, Raigarh, Bilaspur, Khairagarh and Jangir-Champa.

Shri Satish Anand, well-known theatre director and Akademi award-winner was the camp director at the workshop. He was assisted by the local coordinator, Shri Yogendra Choubey, an alumnus of the National School of Drama, New Delhi.

Well-known theatre personalities imparted training in different aspects of theatre. The faculty members included Satish Anand, Delhi (Acting: Voice & Speech/Text Reading & Analysis); Yogendra Choubey, Raigarh (Acting): Gyandev Singh, Khairagarh (Yoga & Movement); Probir Guha, Kolkata (Improvisation & Movement); P.Gopinath, Thiruvananthapuram (Kalaripayattu); Suman Kumar, Delhi (Scenic Design & Costume Design); Lokendra Trivedi, Delhi (Theatre Music); Mirza Masood, Raipur (Creating Performance Text); Niranjana Goswami, Kolkata (Mime); Rajkamal Nayak, Raipur (Theatre of Poetry); A.N. Roy, Khairagarh (Theatre Management);

Badri Singh Kathariha, Bhopal (Make-up); Dinesh Thakur, Mumbai (Production Process); Suresh Bhardwaj, Delhi (Lighting); Devendra Raj Ankur, Delhi (Overview of World Theatre, Indian Theatre and Kahani ka Rangmanch; i.e., Theatre in story format); and Dr Om Prakash Bharati, Deputy Secretary, Drama, Sangeet Natak Akademi.

To give the participants a fair idea of the folk traditions of Chhattisgarh, performances of different regional folk theatre forms were organized. The performances included Nacha by Dileep Tarak, Balram Tarak & Party, Bans Geet by Nakul Yadav and Party, Devar Karma songs and dance by Shanti Devar and Party; folk music by P.C. Lal Yadav and Group; and Chandaini by Ramadhar Sahu and Rakesh Tiwari. Dr Kaptan Singh, Dr Mandavi Singh, Dr I.D. Tewari and Dr Bharat Patel gave detailed lectures on yoga, dance, Shakespeare's theatre and folk songs and dances of Chhattisgarh.

Video/CD screening of the following plays were arranged for the benefit of participants: *Anveshak* (Hindi), written by Pratap Sehgal, directed by Satish Anand; *Mrichchhakatikam* (in Bidesia style), written by Shudrak, directed by Satish Anand; *Daaku* (Hindi), written by Mudrarakshas, directed by Satish Anand; *Khul Ja Sim Sim* (Hindi), by Chandrasekhar Kambar, directed by B.V. Karanth; *Tughlaq* (Hindustani), written by Girish Karnad, directed by Dinesh Thakur; *Rani Dayee* (Hindi), written by Nandkishore Tiwari, directed by Yogendra Choubey.

Some scenes from films of Charlie Chaplin were also screened.

The valedictory function was organized on 1 August. Prof. Geeta Pental, Vice-Chancellor, Indira Kala Sangeet Vishwavidyalaya was the Chief Guest and gave away certificates to the participants. The Workshop Director, Shri Satish Anand, read out the workshop report to the gathering of theatre personalities and artists from the State. The chief attraction, however, was the dramatic presentation got up by participants in the workshop.

Nritya Pratibha, Dehradun: 21-24 July 2007

Sangeet Natak Akademi organized Nritya Pratibha, a festival of young dancers, at Dehradun from 21 to 24 July 2007 in collaboration with Rural Entrepreneurship and Cultural Heritage (REACH) and Oil and Natural Gas corporation (ONGC). The festival focused on young dance talent in northern India; the dancers featured came from the States of Jammu & Kashmir, Punjab, Haryana, Uttar Pradesh, Uttarakhand and Delhi. For wider representation of dance styles in this all-India event, a few dancers from States other than the above were also included. The festival was inaugurated by Shri Harbans Lal Kapoor, Speaker, Legislative Assembly, Uttarakhand, on 21 July at IGNFRA Auditorium, and the festival was held at AMN Ghosh Auditorium, Dehradun, from 22 to 24 July. A festival of choreographic works, Nritya Kriti was presented at Ahmedabad from 24 to 26 March 2008. The festival was inaugurated by Smt. Kumudini Lakhia and Shri Varun Maira, Principal Secretary (Culture), Government of Gujarat at Tagore Hall, Ahmedabad.

Nritya Kriti was the first festival of its kind presented by Sangeet Natak Akademi. Second-generation choreographers such as Priti Patel, Madhu Natraj, Sangeeta Sharma, Jhelum Paranjape and Lokendrajit Singh presented their work in the festival. Artists of Nritya Bharati, Pune, also presented the choreographic works of Smt. Rohini Bhate, an eminent choreographer, in the event. The programme follows:

Traditional Puppetry Performances: Meghdoot Theatre, New Delhi

As a new initiative, the Akademi has started presenting programmes of traditional puppetry at Meghdoot Theatre, Rabindra Bhavan in New Delhi. The following programmes were held at Meghdoot Theatre II during this period:

ESTABLISHMENT OF NATIONAL CENTRES FOR SPECIALIZED TRAINING IN MUSIC AND DANCE

Under the Scheme of Establishment of National Centres for Specialised Training, the Akademi set up three national projects focusing on Sattriya dance and allied traditions of Assam, Chhau dances of Mayurbhanj (Orissa) and Seraikella (Jharkhand), and Kutiyattam, the Sanskrit theatre of Kerala. These projects — started in 2002, 1994 and 1991 respectively — have been designed as total-care programmes providing substantial support to the art forms, which may in the long run lead to the establishment of national centres of these arts or help develop the existing institutions as nationally important centres of learning and practice of these arts. Each of these projects provide for training

activities, production and performance opportunities, instituting new festivals dedicated to these arts, and support by way of research, documentation, etc.

I. Project of Support to Kutiyattam

In May 1991, the Akademi launched the Project of Support to Kutiyattam, the classical Sanskrit theatre of Kerala, with a view to ensure and support a systematic process of transmission of the art from ageing gurus to the younger generation, and to provide performance opportunities to trained artists in the field, thereby reviving these arts.

Margi, Thiruvananthapuram

Margi at Thiruvananthapuram is an institution working for the promotion of Kutiyattam and other performing arts of Kerala. The institution was identified by the Akademi as a centre for providing regular performance opportunities to trained artists. Under the project, the Akademi has been supporting 24 performances in a year (two performances in a month) at Thiruvananthapuram. Revival and production of old plays under Guru Kochukuttan Chakyar was also started in July 2000. This programme is directed at building up a platform for Kutiyattam performances and thereby providing a reliable base for the practice of the art.

Ammannur Chachu Chakyar Smaraka Gurukulam, Irinjalakuda

The Akademi is providing financial assistance to the Gurukulam to developing this institution as a pivotal centre for training in Kutiyattam under Guru Ammannur Madhava Chakyar. The programme provides for remuneration to teachers and accompanists as also scholarships to the selected trainees. Financial support for twelve performances by trainees at Irinjalakuda and six outreach performances is being given as part of the programme.

Training in Mizhavu-playing under Guru P.K. Narayan Nambiar and Pathakam and Vidushuka's roles at Lakkidi are also a part of the project.

Kerala Kalamandalam, Cheruthuruthy

Kerala Kalamandalam, Cheruthuruthy, a State institution in the field, is being provided financial support for twelve outreach performances in a year. The performances are planned in collaboration with local organizations in various parts of the State.

II. Project of Support to Chhau Dances

The Project of Support to Chhau Dances of Mayurbhanj and Seraikella was launched in 1994 in order to reinvigorate the process of learning and performing these dances by ensuring adequate financial assistance and transmission of the arts to the future generation. The project also supports the ongoing work of codification, documentation, and standardization of the training methodology, the accompanying music, the repertoire, the costume and masks. Further, it provides financial assistance to impoverished senior artists from 50 and 60 years of age.

Mayurbhanj Chhau

The Akademi started the training programme for revival and development of Chhau dances of the Mayurbhanj region. At present, Shri Alekh Niranjana Bisoi and Shri Ajay Baitha are engaged as Dance Teachers. Shri Bighnaraj Dhada trains students in Dhol, Shri Bidesi Baitha in Mohuri, and Shri Mihir Kumar Das in music. In addition, Shri Rama Kanta Sen and Shri Rama Chandra Das are engaged as Assistant Teachers in Mayurbhanj. Shri Trilochan Mohanta is engaged as Teacher at Rairangpur. The Project has its own repertory with trained artists in dance and music who are regularly performing in dance festivals organized by the Akademi in various parts of the country. Under the scheme the Akademi also provides financial support for organizing Chaitra Parva, with which festival Chhau Dances are traditionally associated.

Seraikella Chhau Dance

Training in Seraikella Chhau dance is being conducted by Guru Jainarayan Samal, assisted by Shri Sukant

Kumar Acharya. Shri Makardwaj Daroga and Shri Bisoi Khandelwal have been teaching in Parikhanda. Training in Shehnai-playing under guru Sudhansu Sekhar Pani, Dhol-playing under Guru Mangla Mukhi, and dance started in September 1998. Extending the training programme, Shri Shashadhar Acharya has been imparting training in Seraikella Chhau dance in Delhi since May 2003.

Training in Mask-making

Under the Akademi's Project of Support to the Chhau Dance of Seraikella, a training programme in mask-making under two Gurus, Shri Sushant Kumar Mahapatra and Shri Kanhai Lal Maharana, with four trainees each was started in May 2002.

On the recommendation of the Review Committee at its meeting held at Jamshedpur on 11 and 12 August 2004, the training programme in dance and music coordinated by Government Chhau Dance Centre at Seraikella has been transferred to Acharya Chhau Nrutya Bichitra. Artists under this project are being sponsored in various festivals being organized by the Akademi as well as other Government agencies.

III. Project of Support to Sattriya Dance and Allied Traditions of Assam

A Project of Support to Sattriya Dance and Allied Traditions of Assam was launched in November 2002 with the objective of preserving and sustaining the tradition in its traditional context and providing for its further development. The project envisages support for training programmes in dance institutions and identified Sattras. Besides training and development of Sattriya dance and music, the project supports research, documentation, and publication on the subject, an annual festival of Sattriya dance, and presentation of Sattriya dance outside Assam.

Under this project, training programmes in dance under Guru Gobind Saikia and Guru Jatin Goswami, in music under Guru Prabhat Sarma, and in Dance and Music under Guru Ghanakanta Bora were started in October 2003.

PROMOTION AND PRESERVATION OF TRADITIONAL PERFORMING ARTS

The scheme supports training in forms of music, dance and theatre which are in danger of extinction. Honorarium to teachers and scholarships to students are paid by the Akademi by way of incentive, the effort being to sustain these arts through the traditional teaching-learning process. Besides training, the scheme also envisages support to young artists from traditional practising families and gharanas who do not receive support in normal course. Following training programmes under the scheme have been initiated:

Training programme in Pakhawaj under Shri Dalchand Sharma (Delhi, Shri Ramakant Pathak (Lucknow) and under Shri Ramashish Pathak (Darbhanga); training programme in Sundari in Pune under Shri Promod Gaikwad; in Sholapur under Shri Bhimanna Jadhav; training in Dhruvad under Shri Inder Kishor Mishra in Betia, Bihar; training in Shehnai under Shri Anant Lal in Delhi; training in Sarangi under Shri Ramzan Khan in Jaipur; training in Mayuri Veena under Shri Kumar Mishra in Lucknow; training in Naqqara under Shri Aggan Khan in Lucknow; training in Nattuvangam under Smt. Indira Ranjan in Chennai; and training in Porattunatakam, folk theatre under Shri Mannur Chandran in Kerala were held during the year.

In addition, training programmes in Kathputli of Rajasthan and shadow puppetry of Orissa (Ravan Chhaya) were also held during the period.

PUBLICATION

The publication programme of the Akademi, initiated soon after its inception in 1953, includes books and monographs on the performing arts and the quarterly journal *Sangeet Natak*. The *Sangeet Natak Akademi News Bulletin* and its Hindi version *Sangeet Natak Samachar* are also published bimonthly. Besides, to promote publishing on music, dance and drama, the

Akademi helps authors and publishers with grants for books and periodicals in English and Indian languages. A list of available Akademi publications is at Appendix V.

Three books on music, dance and drama were published during this period: (1) *Rabindra Nath Tagore: One Hundred Songs in Staff Notation* compiled by Indira Devi Chaudhurani; (2) *Classical Indian Dance in Literature and the Arts* by Kapila Vatsyayan; and (3) *Indian Drama in Retrospect* (with an introduction by Jayant Kastuar). While the first two are reprints of titles that have remained in demand, the third is an edited work comprising papers presented in the first Drama Seminar organized by the Akademi in 1956.

One issue each of *Sangeet Natak* (Volume 41, Issue No. 1, 2007), the *Sangeet Natak Akademi News Bulletin* (No. 19, 2007), and *Sangeet Natak Samachar* (No. 11, 2007) were published during the period.

DOCUMENTATION

During 2007-2008, 8,765 black-and-white and colour photographs, 345 hours of video recordings, and 102 hours of audio recordings were added to the Archives of the Akademi. The total holdings of the Archives (up to March 2008) stands at 2,11,187 black-and-white and colour photographs, 40,443 colour slides, 6,583 hours of video recordings and 7,164 hours of audio recordings and approximately 1.44 lakh feet of 16 mm film material.

Over the years, the Akademi has built up a large archive of audio/video tapes, photographs and films on the performing arts. Since 1981, it has also added video tapes to its holdings. The material is disseminated through public facilities for audio and video viewing, music dubbing, and film projection. Material from the Akademi's archives has been extensively used in publications, films, television, and for research on the performing arts of India. A list of audio/video recordings during the year is at Appendix VI.

GALLERY OF MUSICAL INSTRUMENTS

Since the establishment of Sangeet Natak Akademi in 1953, the Akademi has been acquiring artefacts relating to the performing arts. Primarily based on this collection, the Gallery of Musical Instruments was opened to the public in 1964 on the ground floor of Rabindra Bhavan. The gallery was inaugurated by renowned violin maestro Lord Yehudi Menuhin. A major thrust of acquisition of objects was given during an exhibition of musical instruments held in Delhi in 1968. The museum now holds more than 2000 objects apart from other related artifacts, out of which a representative permanent display has been made in the Gallery of Musical Instruments. The collection

comprises musical instruments, masks, puppets, headgear, costumes and other artefacts related to the performing arts, besides some musical instruments received as gifts from other countries.

During the period under report, a permanent display of masks has been put up in the corridor adjacent to the museum and a gallery of masks has been created as an adjunct to the gallery of musical instruments. There are about one hundred masks of different styles displayed in these two places. During the period more than a thousand visitors visited the gallery of musical instruments and the gallery of masks. This year the gallery mounted an exhibition of 200 puppets and associated musical instruments at Chandigarh; more than 5000 people visited the exhibition. The museum and the gallery cater to the needs of students, musicologists, musicians, and the general public with a special interest in the performing arts heritage of India.

LIBRARY AND AUDIO-VISUAL LIBRARY

The Akademi's library has over the years acquired a specialized collection of books on the performing arts, many of which are rare and out of print. Catering chiefly to students and researchers in the performing arts, the library receives about a hundred and fifty Indian and foreign periodicals. The total collection now stands at 24,052 books in addition to 928 received by way of gift.

The collection of the audio-visual library now stands at 9,827 discs, 761 pre-recorded cassettes from the archives of the Akademi, 92 video cassettes of dance, drama, and music; 1,602 commercial audio cassettes; 154 gifted audio cassettes and 1,072 compact discs, 8 gifted compact discs, 51 video compact discs (VCDs), 6 gifted VCDs of Indian music, and two DVDs of Bharatanatyam.

Automation and upgradation of software enabling the library to be multi-user are under way. This will facilitate retro-conversion of data related to book holdings of the library.

GRANTS TO CULTURAL INSTITUTIONS AND INDIVIDUALS

Since its inception, the Akademi has been rendering financial assistance to music, dance and theatre institutions and individuals. The Grants Committee, which met on 14, 15 and 25-26 July 2007, considered 613 applications and recommended grants amounting to Rs. 1,38,85,000 to 456 cultural Institutions of the country (Appendix VII, VIII and IX). Further, Rs. 3,15,000 was recommended to nine puppet groups. (Appendix X).

INTER-STATE CULTURAL EXCHANGE PROGRAMME

The Inter-State Cultural Exchange Programme of the Akademi has been operative since 1981. The scheme envisages a programme actively implemented and sponsored by the State governments, where the Akademi subsidises and coordinates exchanges of select groups/individual artists between various States and Union Territories of the country. The financial responsibility between Sangeet Natak Akademi and the States is at 1:1 ratio. However, for the North-eastern States, Sikkim, and Jammu & Kashmir, the Akademi subsidises the entire expenditure incurred by these states. A statement of exchanges during the year is at Appendix IV.

CULTURAL EXCHANGE PROGRAMME BETWEEN INDIA AND OTHER COUNTRIES

The bilateral Cultural Exchange Programme implemented by the Akademi on behalf of the Ministry of Culture consists mainly of exchange of information and material such as books and tapes on the performing arts. However, on occasion, the Akademi has also organized performances and exhibitions abroad at the instance of the Government of India

in fulfillment of specific items of Cultural Exchange Programme.

In the period under report, the Akademi was called upon to present classical and folk dances in the United States as part of the festival titled 'Incredible India @ 60'.

Incredible India @ 60, New York, USA: 23-26 September 2007

The Ministry of Tourism and the Ministry of Culture, Government of India, in association with the Ministry of Textiles and CII organized the festival from 23 to 26 September 2007 celebrating sixty years of India's Independence. At the request of the Ministry of Culture, Sangeet Natak Akademi presented programmes of classical dances of India and of folk and tribal dances of various States — namely, Manipur, Mizoram, Nagaland, Sikkim, Punjab, Uttar Pradesh, Gujarat, and West Bengal — during the festival. The inaugural event was presented on 23 September at the Avery Fisher Auditorium, Lincoln Centre, New York. The folk music and dances of India were presented at Bryant Park from 23 to 25 September and at the South Street Sea Port from 24 to 26 September 2007. These were choreographed by Smt. Maitryee Pahari.

A short invocatory composition was presented by Smt. Maitryee Pahari with Pung Cholom, Yakshagana, Theyyam and Mohiniattam, followed by a group choreographic presentation by Smt. Madhavi Mudgal comprising Odissi, Bharatanatyam, Kathakali, Manipuri and Kathak. The Odissi group was led by Smt. Madhavi Mudgal. The Bharatanatyam group was led by Smt. Geeta Chandran. The Manipuri group was led by Smt. Charu Sija Mathur and the Mohiniattam group was led by Smt. Vijaya Lakshmi. The repertory of Kathak Kendra was led by Smt. Prerana Shrimali and the Kathakali group was composed of artists of the International Centre for Kathakali. A total number of 37 classical artists were presented at Lincoln Centre. A repeat show was held along with solo performances by Smt. Madhavi Mudgal, Odissi, Smt. Geeta Chandran, Bharatanatyam, Smt. Charu

Sija Mathur, Manipuri; and Smt. Prerana Shrimali, Kathak.

The inaugural programme was held at the Lincoln Centre which among others was attended by Shri Pranab Mukherjee, Minister for External Affairs, Shri P. Chidambaram, Minister for Finance, Shri S. Wagela, Minister for Textiles and some Chief Ministers from the North-eastern States. The Indian Ambassador to the United States, Shri Ronen Sen was also present. The welcome address was given by Shri Sunil Mittal, President of CII, and this was followed by a brief speech by the Minister for External Affairs, Shri Pranab Mukherjee. The inauguration at Lincoln Centre was compered by Shri Kabir Bedi.

The performances of folk dances of India commenced at Brayant Park on 23 September 2007. The programme started at 11.00 a.m. and ended at 9.00 p.m. every day. The programme at the South Street Sea Port also began at 11.00 a.m. and ended daily at 9.00 p.m. Apart from folk and tribal dances of India the Akademi also presented the Colonial Cousins, Remo Fernandes and Shivamani groups invited directly by the Ministry of Tourism. The performances at Bryant Park and South Street Sea Port were presented by Smt. Maitryee Pahari.

PROGRESSIVE USE OF HINDI

The Official Language Implementation Committee of the Akademi ensures compliance of the official language policy in the Akademi. Meetings of the Official Language Implementation Committee are convened regularly to ensure the progressive use of Hindi in day-to-day work of the Academy.

A Hindi fortnight, commonly known as Hindi Pakhwara, was organized in the Akademi from 14 to 28 September 2007 for promotion of Hindi in day-to-day official work, as advised by the Ministry of Culture. A number of competitions were held to encourage employers to do their regular work in Hindi. The winners of various competitions were

given cash awards and certificates by the Secretary in a function held on 25 October 2007. Cash awards were also given to the employees on the basis of work done by them in Hindi as per the scheme of the Government.

During the period under report, Hindi workshops were held on 4 April 2007, 25 June 2007 and 26 June 2007, 11 September 2007, 27 December 2007, and 26 March 2008.

AKADEMI'S NEWS BULLETIN IN HINDI

Sangeet Natak Akademi has been publishing its *Sangeet Natak Akademi News Bulletin* in English for disseminating information with regard to activities of the Akademi. In view of recommendations of the Official Language Committee and to reach out to a larger segment of performing artists, the Akademi started publishing a Hindi version of the *News Bulletin*, titled *Sangeet Natak Samachar* in December 2005. The Hindi *Samachar* is being mailed together with the English language *Bulletin* to artists, institutions, and the general public.

BUDGET AND ACCOUNTS

The Akademi receives a grant-in-aid from the Ministry of Culture, Government of India to meet the expenditure on its Plan and Non-Plan activities. The budget of the Akademi in 2007-08 for Non-Plan activities was Rs. 610 lakhs and for Plan activities Rs. 1,050 lakhs; the amount reimbursed for work in the North-east was Rs. 394.25 lakhs.

The consolidated statement of annual accounts comprising the Receipts and Payments Account, Income and Expenditure Account, and the 2007-2008 Balance Sheet of the Sangeet Natak Akademi and its constituent units — Jawaharlal Nehru Manipur Dance Academy, Imphal, Kathak Kendra, New Delhi, and Rabindra Rangashala, New Delhi — are at Annexure XV.

In the period under report, the Akademi mourned the passing of several eminent personalities in the field of performing arts, including Awardees of past years. The Akademi pays its homage to the memory of the deceased.

Smt. Roshen Alkazi, eminent costume designer, who received the Sangeet Natak Akademi in 1990, passed away on 28 August 2007.

Shri Surendra Nath Jena, eminent Odissi exponent who received the Sangeet Natak Akademi Award in 2006, passed away on 8 October 2007.

Shri Kailash Pandya, eminent theatre director who received the Sangeet Natak Akademi Award in 1993, passed away on 24 December 2007.

Km. Shanta Rao, eminent Bharatanatyam dancer who received the Sangeet Natak Akademi Award in 1970, passed away on 28 December 2007.

Shri Narendra Sharma, eminent choreographer and creative dancer who received the Sangeet Natak Akademi Award in 1976, passed away on 14 January 2008.

Smt. Shiela Bhatia, eminent theatre director who received the Sangeet Natak Akademi Award in 1982, passed away on 17 February 2008.

KATHAK KENDRA, NEW DELHI

Kathak Kendra, a constituent unit of Sangeet Natak Akademi, was established in 1964. Housed in Bahawalpur House, it is the premier teaching institution in the country in the field of Kathak dance. Eminent masters of Kathak dance and Hindustani music including Lachchhu Maharaj, Shambhu Maharaj, Sunder Prasad, Kundanlal Gangani, Mohan Rao Kalyanpurkar, Purushottam Das, Birju Maharaj, Durga Lal, Hafiz Ali Khan, Mushtaq Hussain Khan, Moinuddin and Aminuddin Dagar have taught here. Kumudini Lakhia, Siddeshwari Devi, and Naina Devi have also taught at the Kendra.

The Kendra offers several courses in Kathak dance: a three-year Foundation Course; a two-year Diploma (Pass) Course; a two-year Diploma (Hons) Course, a two-year Post-Diploma course; and a three-year Diploma course for foreigners. Apart from dance courses, the Kendra offers a one-year Certificate course, a three-year Certificate course, a three-year Diploma course and a two-year Post-Diploma course in Tabla and Pakhawaj-playing. The Kathak Kendra also provides facilities for ex-students who want to seek further guidance from gurus for short terms. They can get themselves registered with the Kendra. It has a girls' hostel which is located in the same premises.

The Kendra's main objective is to train proficient dancers committed to pursuing the art as a profession. Gifted gurus including Munna Shukla, Urmila Nagar, Rajendra Gangani, Geetanjali Lal, Krishan Mohan Misra, Govind Prasad Chakraborty, Ram Kishore Das, Jai Kishan Maharaj and Amir Ahmed Khan were part of the teaching faculty during the year. Many dancers trained at Kathak Kendra have received acclaim both for solo dancing and for their choreographic work in India and abroad.

The management of the Kathak Kendra is vested in the Executive Board of the Sangeet Natak Akademi, which is assisted by the Advisory Committee and the Director of the Kathak Kendra. Members of the

Committee are nominated by the Board for a tenure of five years and is coterminous with the term of the General Council of the Akademi. The Vice-Chairman of Sangeet Natak Akademi is the Chairman of the Advisory Committee of Kathak Kendra.

Annual Examination 2006-2007

Stage Performance Test (2006-2007)

As part of the Annual Examination for the Academic Session 2006-2007, a Stage Performance Test was held at the auditorium of Triveni Kala Sangam, New Delhi, from 30 April to 4 May 2007 in which 24 students of the final year of advance courses in dance, three in Tabla and one in Pakhawaj appeared. The programme presented in this festival is designed to evaluate the competence of the Kendra's final year students of the Diploma (for foreigners), Diploma (Hons.) and Post-diploma courses before a panel of external examiners.

Summer Vacation 2006-2007

The teaching faculty of the Kendra closed for summer vacations from 16 May to 30 June 2007.

New Admissions 2007-2008

Advertisements for admission at the Kendra for the 2007-2008 session were published in different newspapers in Delhi and outside. The Admission Committee comprising teachers of the Kendra interviewed 250 candidates for the pre-admission test. Pre-admission tests for different courses at the Kendra were held from 14 July to 19 July 2007 this year.

Foreign Students

House rent subsidy was provided to ten eligible male outstation students @ Rs. 2000 per month during the 2007-2008 academic session.

At the 10th Celebration of the India Habitat Centre, the Repertory of Kathak Kendra presented a group choreography, 'Sankriti', on 25 November 2007.

Kendra's Annual Event

Kathak Utsav was held at Jalandhar from 1 to 4 December 2007 at Apeejay College of Fine Arts, Jalandhar, in collaboration with Punjab Arts Council, Chandigarh. Solo and duet performances were held in this programme.

Kathak Mahotsava, 2008

Kathak Mahotsava, the annual event of the Kendra, is held every year in February/March. The five-day long annual festival was held at Jaipur from 13 to 17 March 2008 in collaboration with the Jaipur Kathak Kendra, Jaipur. The festival was inaugurated by the Governor of Rajasthan. Solo, duet and group performances, and lecture-demonstrations were held on this occasion.

JAWAHARLAL NEHRU MANIPUR DANCE ACADEMY, IMPHAL

The first Prime Minister of India, Pandit Jawaharlal Nehru, on his maiden visit to Manipur in 1952 witnessed Ras Leela at the Royal Palace at the invitation of His Highness Maharaja Bodhachandra Singh. Pandit Nehru was so moved by the spectacle of Ras that he took the initiative of founding an institution of Manipuri dance in Imphal.

Thus was born the Manipur Dance College. Established on 1 April 1954 at the Babupara Theatre Hall in Imphal, the College was later renamed Jawaharlal Nehru Manipur Dance Academy on 8 June 1964 after the demise of Pandit Nehru to honour his contribution to the founding of the Academy.

In the Academy's initial stage of growth, Guru Meisnam Amubi Singh and Guru Haobam Atomba Singh pioneered the movement to build up the institution. It was their tireless effort, and the enduring support of the other Gurus in those early days, that saw the flourishing of the Academy into a reputed institution of Manipuri dance.

The Jawaharlal Nehru Manipur Dance Academy has been a constituent unit of Sangeet Natak Akademi since 1957.

Academic Unit

The courses offered at the Academy are a Foundation Course (three years); a Diploma Course (three years) and a Post-diploma Course (three years). The subjects taught are Ras, Lai Haraoba, Nat Sankirtan (Ishei), Nat-Sankirtan (Cholom), Nat Sankirtan (Pung), Tribal Dance and Thang-ta (Foundation and Diploma Course only for the latter two).

Scholarships

The Academy provides five scholarships of Rs. 200 per month for three years to the best students of dance and Sankirtan Post-Diploma courses, one each in Raas, Lai Haraoba, Pung, Ishei and Cholom. Ten scholarships of Rs. 150 per month are provided for three years to the five best students each of dance

and Sankirtan Diploma courses. A scholarship of Rs. 100 per month is given for one year and Second Year Foundation course on the performance in the annual examination. A number of free studentships are provided to meritorious students in all the courses.

Medals

The following gold medals are awarded to deserving students. The Rajyapal Gold Medal is awarded to the highest-scoring student of Post-Diploma Course (Final Year). The Lourembam Tombi Gold Medal in Ras is awarded to the best performer in the Post-diploma course Final Year in Ras. The Guru Gulapi Gold Medal in Sankirtan is awarded to the best performer in the Diploma Course Final Year in Sankirtan. The Sovita N. Mehta Gold Medal in dance is awarded to the best performer in the Diploma Course Final Year in Dance. The Khukhu Sarkar Gold Medal in Ras is given on the basis of performance in the Diploma course Final Year in Ras.

Production Unit

The Production Unit of the Academy, established in 1975, is the best known repertory of Manipuri dance and music. It has produced dance-dramas on varied themes and has been featured in all important festivals of dance in India and abroad. The unit has produced 32 dance-dramas till date:

53rd Foundation Day

The 53rd Foundation day of JNMDA was held on 1 April 2006 at the Academy Auditorium. Dr. S.S. Sidhu, Governor of Manipur and Chairman of JNMDA, and Prof. L. Damodar Singh, Vice-Chairman of JNMDA, graced the occasion as Chief Guest and President respectively.

The gold medalists presented solo items of Manipuri dance and music. Other students of the Academy also presented a programme of Manipuri dance and music. The function was well attended and widely covered by print and electronic media.

New Session

The Academic Session of the Academy started on 4 April 2007.

Students on roll

The total students on roll for the year 2007-08 for all courses was 621, out of which 274 students did not appear in the Annual Examination.

Annual Examinations

The Annual Examinations for all courses were held from 13 to 23 February 2008. The services of 28 external examiners were utilized for conducting the examinations in addition to the existing gurus of the Academy.

Programmes and Other Activities

Lai-haraoba Festival 2007

A seven-day Lai-haraoba festival of Lord Ibudhou Chakhaba was held at the Academy complex from 22 to 28 April 2007. All the Gurus, artists and students of the Academy took part in the Lai-haraoba festival. It is an annual feature of the Academy's activities.

Ahangkar Bhangam

The inaugural show of the dance-drama, *Ahangkar Bhangam* was held on 14 January 2008 at the JNMDA Auditorium. Dr. S.S. Sidhu, Governor of Manipur and Chairman, JNMDA, inaugurated the production in the presence of Shri A. Shyam Sharma, noted film personality. The show was well attended and received appreciation from the audience. The function was widely covered by electronic and print media.

Workshop and Lec-Dem Programme

A five-day workshop on Seraikella Chhau dance was conducted at JNMDA by Shri Shashadhar Acharya with the artists of the Production Unit from 17 to 22 August 2007. Shri Jayant Kastuar, Secretary, Sangeet Natak Akademi, delivered a two-hour lecture-demonstration on Kathak dance on 29 November 2007 at the Auditorium of JNMDA. Gurus, students, artists and officials of the Academy participated in the programme.

Presentation of Nata-sankirtana and Maharas at Santineketan

A 42-member troupe of the Academy presented Nata-sankirtana and Maharas in traditional style as the inaugural item of the Festival of Manipuri Classical Dance organized by the Manipur State Kala Akademi, Viswa-Bharati, Santineketan, and Sangeet Natak Akademi from 1 to 14 February 2008 at Sangit Bhavana of Viswa-Bharati.

Lecture-demonstrations on Manipuri dance and Nata-sankirtana were also held on 2 and 3 February by Gurus of the Academy — Shri Lakpati Singh, Smt.

Ksh Thouranishabi Devi, Smt. Y. Gambhini Devi and Smt. Kh. Leibaklotpi Devi. Both the programmes were widely acclaimed and covered by the media.

Octave Festival 2008

A 35-member troupe of the Academy participated in the Octave Festival of North-eastern India at Thiruvananthapuram from 16 to 23 February 2008, organized by Sangeet Natak Akademi, New Delhi. The group presented Nata-Sankirtana, Maharas, and the dance-drama, Keibul Lamjao in the festival.

- iv. to encourage the exchange of ideas and enrichment of techniques between the different regions in regard to the arts of music, dance and drama :
- v. to encourage the establishment of theatre centres, on the basis of regional languages, and cooperation among different theatre centres :
- vi. to encourage the setting up of institutions providing training in the art of theatre, including instruction in actor's training, study of stagecraft and production of plays :
- vii. to encourage and assist production of new plays by awarding prizes and distinctions :
- viii. to publish literature on Indian music, dance and drama including reference works such as an illustrated dictionary or handbook of technical terms :
- ix. to give recognition to and other wise assist meritorious theatrical organizations :
- x. to encourage the development of amateur dramatic activity, children's theatre, the open air theatre and the rural theatre in its various forms :
- xi. to revive and preserve folk music. Folk dance and folk drama in different regions of the country and to encourage the development of community music, martial music and other types of music:
- xii. to sponsor music, dance and drama festivals, seminars, conferences on all-India basis and to encourage such regional festivals:
- xiii. to award prizes and distinctions and to give recognition to individual artistes for outstanding achievement in the fields of music, dance and drama :
- xiv. to take suitable steps for the maintenance of proper and adequate standards of education in music, dance and drama and with that object to organize research in the teaching of the said subjects :
- xv. to foster cultural contracts between the different regions of the country and also with other countries in the fields of music, dance and drama.

SCHEDULE 24 - SIGNIFICANT ACCOUNTING POLICIES

1 ACCOUNTING CONVENTION

The financial statements are prepared on the basis of historical cost convention, unless otherwise stated and on the basis of generally accepted accounting principles followed in India with accrual method of accounting except stated otherwise.

2 INVESTMENTS

2.1. Investments classified as "long term investments" are carried at cost. Provision for decline, other than temporary, is made in carrying cost of such investments.

2.2. Investments classified as "Current" is carried at lower of cost and fair value. Provision for shortfall on the value of such investments is made for each investment considered individually and not on a global basis.

2.3. Cost includes acquisition expenses like brokerage, transfer stamps.

3 FIXED ASSETS

3.1. Fixed assets are stated at cost of acquisition inclusive of inward freight, duties and taxes and incidental and direct expenses related to the acquisition. In respect of projects involving construction, related pre-operational expenses (including interest on loans for specific project prior to its completion), form part of the value of the assets capitalized.

3.2. Fixed Assets received by way of non-monetary grants, other than towards the Corpus Fund, are capitalized at values stated, by corresponding credit to capital Reserve / Fixed Assets Fund.

4 DEPRECIATION

4.1 Depreciation is provided on written down value method as per rates specified in the Income-tax Act, 1961.

4.2 In respect of additions to/deductions from fixed assets during the year, depreciation is considered on pro-rata basis.

5 MISCELLANEOUS EXPENDITURE

Deferred revenue expenditure is written off over a period of 5 years from the year it is incurred.

6 GOVERNMENT GRANTS/SUBSIDIES

6.1 Government grants of the nature of contribution towards capital cost of setting up projects are treated as Capital Reserve.

6.2 Government grants/subsidy are accounted on realization basis.

7 FOREIGN CURRENCY TRANSACTIONS

7.1 Transactions denominated in foreign currency are accounted at the exchange rate prevailing at the date of the transaction.

7.2 Current assets, foreign currency loans and current liabilities are converted at the exchange rate prevailing as at the year end and the resultant gain/loss is adjusted to cost of fixed assets, if the foreign currency liability relates to fixed assets, and in other cases is considered to revenue.

8 RETIREMENT BENEFITS

8.1 Gratuity payable on death/retirement and accumulated leave encashment benefit of the employees of the Akademi is accounted on payment basis.

- 8 During the earlier period Kathak Kendra capitalized land for Rs. 11.38 lacs and charged ground rent due upto 31.03.2007 on the basis of available records and adjusted advance of Rs. 21 lacs, given to Land & Development Office to that extent. Ground rent upto 31-03-2008 has also been provided during this period. However final adjustment on this account will be made till the execution of Memorandum of Understanding with the relevant authority.
- 9 During the period under audit, the Kathak Kendra has opened & established one more Peripheral Centre on rented premises in East Delhi. The others are being run in North and South Delhi. Approximately 192 students are getting benefits in these centres.
- 10 The expenditure on maintenance of Rabindra Rangshala amounting to Rs. 25.59 Lacs pertaining to the period prior to FY 2002-03 was charged to final expense head at the time of making payment to CCW (Civil & Electrical) AIR. However since FY 2002-03 after suggestion made by the CAG, payment made to CCW (Civil & Electrical)AIR has been showing as advance & debited to final expenses head only after receiving Statement of Expenditure duly approved by the competent authority. Regular efforts are being made to obtain the expenditure statement relating to these previous years so that resultant net income / expenses could be recognized / booked as the case may be as prior period income / expenditure in the books of account of the Rangshala.
- 11 During the period under review, there has been fixation under ACP scheme in the pay scale of staff working in Ravindra Rangshala, however liability of Ravindra Rangshala towards this fixation will be provided after quantifying the actual amount to be paid to the concerned staff.
- 12 The ownership of the land and building at Rabindra Rangshala does not lie with the Akademi. No depreciation has been provided in respect of these assets.
- 13 Priced publications stock have been taken at 1/3 rd of the sale price and journal stock has been taken at sale price. During the year Priced Publications & Journals worth Rs. 32,330 have been gifted as complimentary copies. During the period under review price of publication/journal have been revised upward by the Akademi.
- 14 During the year the Akademi has capitalized Library Books worth Rs. 11,185/- received as Gifts, which has been shown as such in the Schedule of Fixed Assets with the corresponding entry in the Schedule of Earmarked Fund under the head Fixed Assets Fund. No Depreciation has been provided on these gifted books. Where the value of gift has not been mentioned notional value of Rs. 1/- has been taken as the value of gift.

- 15 The Department of Culture, Ministry of Tourism & Culture, Govt. of India fund the Sangeet Natak Akademi. The summarised position of the Grants / Financial Assistance for specific purpose received by the Akademi for the year ending 31st March, 2008 is as follows:

- 17 Depreciation has not been provided for on Museum Items and Documentary Films. In order to comply with Income Tax Rules the Akademi has discontinued it's policy relating to provision of 100% depreciation on assets costing Rs. 5000/- or less. Now depreciation on such assets are provided at the rate applicable to the block in which the said assets fall.
- 18 Figures of the previous year have been regrouped, rearranged and recasted wherever considered necessary.
- 19 Schedule 1 to 25 and Annexures 1 to 16 are annexed to and form an integral part of the balance sheet as at 31.03.2008 and the Income and Expenditure account for the year ended on that date.

We have audited the attached Balance Sheet of Sangeet Natak Akademi as at 31st March 2008 and Income & Expenditure Accounts/Receipts & Payments Account for the year ended on that date under Section 20(1) of the Comptroller & Auditor General's (Duties, Powers & Conditions of Service) Act 1971. The audit has been entrusted for the period upto 2008-09. These financial statements include the accounts of 3 units/branches of the Sangeet Natak Akademi. These financial statements are the responsibility of the Sangeet Natak Akademi's management. Our responsibility is to express an opinion on these financial statements based on our audit.
2. This separate Audit Report Contains the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment only with regard to classification. Conformity with the best accounting practices, accounting standards and disclosure norms, etc. Audit observation on financial transactions with regard to compliance with the Law, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspects etc., if any are reported through Inspection Reports/CAG's Audit Reports separately,
3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free, from material misstatements. An Audit examining, on a test basis, evidences supporting the amounts and disclosure in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.
4. Based on our audit, we report that:

B Grant in aid

During 2007-08, the Akademi received grants from the Ministry of Culture amounting to Rs. 20.63 crore (Plan Rs. 10.50 crore, NER Rs. 3,94crore and Non Plan Rs. 6.19crore). It had its own receipts of Rs. 32.20 lakh (Plan Rs. 8.64 lakh and Non Plan Rs. 23.56 lakh). It utilised Rs. 21.31 crore (Plan Rs, 10.51 crore, NER Rs. 4.32 crore and Non Plan Rs. 6.48 crore. It also received a Plan grant of Rs.2 crore for the Incredible India project and Rs. 1.3 crore for Days of China in India. It utilised Rs. 4.00 crore. The excess expenditure was met from the Capital Fund of the Akademi.

- V Subject to our observations in the preceding paragraphs, we report, that the Balance Sheet and Income & Expenditure Account/Receipt and Payment Account dealt with by this report are in agreement with the books of accounts.
